Dear Mr. Halloran:

This office represents Maya Online Broadband Network (HK) Co., Ltd. (" Maya HK").

It has come to our attention that in the recent past, you have secretly communicated with Eastern Communications Co. Ltd. ("Eastcom") on behalf of a private sector party involved in litigation with Maya HK, and you have used the color of your office to support an attempt to intimidate Eastcom into breaching a domain name services agreement entered into in the People's Republic of China ("PRC"), under applicable PRC law, which agreement is valid and subsisting under PRC law.

Besides being ultra vires and antithetical to (1) ICANN's tax-exempt status and (2) ICANN's stated (and congressionally mandated) policy of neutrality and non-interference in private commercial litigation matters, your secretive action is particularly inexplicable in view of the Appeal No. 02-1112 pending before the United States Court of Appeals for the Fourth Circuit. A copy of Maya HK's opening brief to the Court of Appeals dated April 1, 2002, accompanies the confirmation copy of this letter.

If Cable News Network ("CNN") has the legal rights it claims to have, it has full access to courts of competent jurisdiction with authority to enforce those rights. That CNN would attempt secretly to use you as a private, extra-judicial "enforcer" of a court judgment is rather dramatic testimony to the voidness and legal unenforceability of the judgment. That you would actually go along with such a secretive, extra-legal scheme of intimidation is regrettable, to put it mildly.

This letter will constitute a formal demand that you immediately rescind and withdraw any communication you have previously issued to Eastcom purporting to take any position on the merits of any claim of Cable News Network, L.P., L.L.P. in the above-entitled litigation, and that you and ICANN cease and desist from any future action purporting to enmesh ICANN in this purely private commercial litigation matter in which the plaintiff deliberately bypassed the Uniform Dispute Resolution Policy administered by ICANN.

We shall expect your response within five (5) days from the date of this letter.

Dear Mr. Dabney:

I have reviewed your 4 April 2002 letter to Mr. Halforan, ICANN's chief registrar liaison, in which you completed about his communication with Eastern Communications Co., an ICANN accredited registrar.

It appears that your letter was written without first checking the facts. I have enclosed a copy of Mr. Halloran's message to EastCom, which apparently gives rise to your careless allegation that Mr. Halloran is guilty of "secretly communicating."

Plainly, this message was helither secret (it was copied to all perties for which Mr. Halloran had addresses). Nor was the communication inappropriate in any way. It merely provides EastCom with a copy of correspondence that ICANN had received asserting that EastCom was in violation of an order of the United States District Court for the Eastern District of Virginia, a court of competent jurisdiction due to EastCom's submission of a Registrar Certificate tendering to that court "complete control and authority over the registration for the CNNEWS COM domain name registration record." (See enclosed Registrar Certificate.)

As an ICANN-accredited registrar, EastCom has contractual responsibilities. These include its obligation under paragraph 3(b) of the Uniform Dispute Resolution Policy to "cancel; transfer or otherwise make changes to domain name registrations [upon its] receipt of an order from a court or arbitral tribunation each case of competent jurisdiction, requiring such action. "EastCom's obligations also include the requirement of subsection ILJ.2 of EastCom's registrar accreditation agreement to abide by applicable laws and governmental regulations."

ICANN expects the registrars it accredits to comply with the contractual obligations they have accepted in their accreditation agreements. It is entirely appropriate for ICANN to enforce those obligations when violations are called to its attention. It appears that the district court has issued an order that the domain name CNNEWS.COM is transferred to Plaintiff Cable News Network



Dear Mr. Touton:

This law firm represents Cable News Network LP, LLLP ("CNN") in connection with the above-referenced civil action (the "Action"). CNN filed the Action under the in rem provisions of the U.S. Anti-cybersquatting Consumer Protection Act alleging that the domain name CNNEWS.COM had been registered and used in bad faith to host a news web site that is directly competitive to CNN's famous CNN.COM site.

Shortly after CNN filed the Action, CNN gave notice to the registrar of the domain name, Eastern Communications Company Limited ("Eastcom"), and requested that Eastcom deposit control of the domain name into the registry of the Court. Eastcom agreed to do so through a Registrar Certificate dated March 9, 2001, and enclosed herewith. Eastcom stated in the Certificate: "Eastcom hereby tenders to the court complete control and authority over the registration for the CNNEWS.COM domain name registration record."

On December 21, 2001, the Court granted summary judgment to CNN in the Action. In an order dated January 11, 2002, the Court ordered the defendant domain name transferred to CNN. A copy of the Order is enclosed.

After receiving the Order, I contacted counsel for Eastcom to request that Eastcom transfer the domain name to CNN. When I did not hear from Eastcom's counsel in response to my first letter, I sent a follow-up letter. To date, I have received no

response of any kind from Eastcom or its counsel, and the domain name continues to be registered in the name of Maya Online Broadband Network (HK) Co. Ltd.

This letter is to request your assistance and the assistance of ICANN in securing transfer of the domain name. It is our understanding that ICANN's agreement with each of its registrars requires that the registrars abide by court orders regarding domain name ownership issues. CNN continues to suffer irreparable injury every day that the domain name remains in the hands of Maya Online for use in operating a competitive web site. We request any assistance you may be able to give us in bringing this matter to resolution, and we are confident that, with input from ICANN, Eastcom will timely transfer of the domain name to CNN.

Please let me know if I can provide you with any further information regarding this matter.

- I have personal knowledge of the facts stated in this Registrar Certificate, and could and would testify to these facts if called as a witness in this matter. I am the director of Information Center of EASTERN COMMUNICATIONS COMPANY LIMITED ('EASTCOM')
- 2. EASTCOM is a registrar of Internet second-level domain names in the top-level domains .COM, .NET, and .ORG.
- Our records indicate that the registrant of the CNNEWS.COM domain name is Maya Online Broadband Network, located at 48th Floor, The Center, 99 Queen's Road Central, Hong Kong.
- 4. Through the deposit of this Registrar Certificate with the Registry of the Court,

 EASTCOM hereby tenders to the Court complete control and authority over the

 registration for the CNNEWS.COM domain name registration record.
- 5. The registration for the domain name CNNEWS.COM is currently active, and EASTCOM will not permit any transfer, suspension, or other modification to the

registration record during the pendency of this action, except upon receipt of an order of the court or a dismissal of all claims concerning the registrant's contractual rights to register or use the subject domain name.

6. This Registrar Certificate shall expire automatically, and control and authority over the registration record of the domain name shall revert to EASTCOM: (i) 14 calendar days from the date of this Registrar Certificate, unless this Registrar Certificate has been filed with the Court during that period and EASTCOM has received a file-stamped copy; or (ii) upon EASTCOM's receipt of an order dismissing all claims concerning the registrant's contractual rights to register or use the subject domain name.

I declare under penalty of perjury that the foregoing is true and correct. Executed on March 9, 2001, at Hangzhou, the People's Republic of China.

Dear Mr. Touton:

We have your letter dated April 4, 2002.

Your letter confirms that on April 2, 2002, Mr. Halloran did indeed secretly communicate with Eastcom, behind Maya HK's back, and for the express purpose of attempting to induce Eastcom to breach an existing registration services agreement with Maya HK. Such action by Eastcom would violate the "applicable laws and government regulations" cited in your April 4 letter, and would further expose both Eastcom and ICANN to substantial liability for damages under Hong Kong and PRC law, to say nothing of California law in ICANN's case.

We enclose an excerpt from the proceedings held December 7, 2001, in the above-entitled action, at which time the Court acknowledged: "This Court doesn't purport to have the power to order anybody in China to do anything." Your suggestion that Eastcom could be "in violation of" or "obliged to comply" with a judgment of a U.S. Court, without the judgment being domesticated in China on notice to all affected parties, is without legal basis as you surely must know. You also are no doubt aware that in a so-called "in rem" proceeding, a Court has no power to issue injunctions and did not do so in this case.

Equally without basis is your suggestion that the Uniform Dispute Resolution Policy ("UDRP") provided some justification for Mr. Halloran's secret communication to Eastcom. The UDRP has not been invoked with respect to the domain name in question and none of its rules, procedures, or substantive legal safeguards have been honored or complied with. Being a UDRP panelist myself, I am quite familiar with what the UDRP does, and does not, require of registrars.

Needless to say, ICANN has no jurisdiction to determine whether the United States District Court for the Eastern District of Virginia was, or was not, a "court of competent jurisdiction" for purposes of terminating Maya HK's rights under a domain name services agreement entered into with Eastcom in the PRC. Particularly in view of the pending Appeal No. 02-1112 before the Fourth Circuit, ICANN acts at its peril if continues, at this time, extra-judicial efforts to intimidate Eastcom into breaching its contract with Maya HK.
